**B Pharmacy: First Year** (<https://www.mahcet.org>)**(1) Maharashtra State Candidature Candidates**

- (i) The candidate should be an Indian National;
- (ii) Passed HSC or its equivalent examination with Physics and Chemistry as compulsory subjects along with one of the Mathematics or Biology and obtained at least 45% marks (at least 40% marks in case of candidates of Backward class categories, Economically Weaker Section and Persons with Disability belonging only to Maharashtra State) in the above subjects taken together;
- (iii) The candidate should have appeared in all the subjects in MHT-CET 2020 and obtain non zero score in MHT-CET 2020.

**(2) All India Candidature Candidates. -**

- (i) The candidate should be an Indian National;
- (ii) Passed HSC or its equivalent examination with Physics and Chemistry as compulsory subjects along with one of the Mathematics or Biology and obtained at least 45% marks (at least 40% marks in case of candidates of Backward class categories, Economically Weaker Section and Persons with Disability belonging only to Maharashtra State) in the above subjects taken together;
- (iii) Should obtain non zero positive score in NEET or the candidate should have appeared in all the subjects in MHT-CET 2020 and obtain non zero score in MHT-CET 2020. However, preference shall be given to the candidate obtaining non zero positive score in NEET over the candidates who obtained non zero score in MHT-CET 2020.

**Direct Second Year (Lateral Entry)- Pharmacy:** (<https://www.mahcet.org>)**For Maharashtra State Candidature Candidate and All India Candidature Candidate, -**

- (i) The candidate should be an Indian National;
- (ii) Passed Diploma Course in Pharmacy with at least 45% marks (at least 40% marks in case of candidates of Backward class categories, Economically Weaker Section and Persons with disability belonging to Maharashtra State only) from an All India Council for Technical Education or Pharmacy Council of India or Central or State Government approved Institution or its equivalent. The revision in the fees if any, by the Fees Regulation Authority- Mumbai will be binding on the students. While taking admission to the college the student will have to pay the full fees as declared by the Fees Regulation Authority-Mumbai/ or competent authority.

Admission of candidate who has been admitted to any course will be treated as finally confirmed only on production of the Eligibility Certificate from concerned University.

**Reporting at institute:**

- i. Candidate shall confirm the admission by paying the requisite amount of fee and by submitting required documents in original as per schedule.
- ii. If a candidate fails to substantiate the claims made at the time of submitting necessary original documents, the candidate forfeits the claim on the allotted seat.

**Original Deposit receipts should be preserved carefully. On completion of course/ cancellation of admission refund of deposit (after deduction of dues if any) will be given only on submission of original deposit receipt.**

**Cancellation of admission:** refer ( <https://www.mahcet.org>)

- (a) The Candidate shall apply online for cancellation and submit duly signed copy of system generated application for cancellation of admission to the institution. Once the candidate submits online request for cancellation, his/her admission shall be treated as cancelled. Upon such cancellation, the candidate shall lose the claim on the seat and such seat shall become available for further allotment. The candidate shall then become entitled to and the Institute shall refund the entire fees to the candidate after deduction of processing charges and return all his/her original documents submitted to the Institute within two days from submission of duly signed copy of system generated application to the Institute;
- (b) Notwithstanding clause (a) above, candidate shall not be entitled to any refund of his/her fee except the Security Deposit and Caution Money Deposit if the online cancellation is effected by the candidate after the cut-off date prescribed by the Competent Authority;

**If the admission is cancelled after the cut- off date of admission declared by the competent Authority there shall be no refund except the security Deposit and Caution Money Deposit (after deduction of dues if any).**

### **Conduct and Discipline**

- (i) Failure of the candidate in making full and correct Statements in the application form and/or suppression of any information and/or submission of false documents shall lead to disqualification of the candidate from the examination or at later stage during the Admission Process such candidate will be debarred from the entire selection process.
- (ii) Adopting any unfair means or engaging in malpractice in the examination shall render a candidate liable for punishment under, “Maharashtra Prevention of Malpractices Act, Universities, Board and Other Specified Examination Act, 1982” and disqualify him/her for examination.
- (iii) Any issue not dealt here-in above will be dealt with, when arising, fully and finally by the Competent Authority.
- (iv) Notwithstanding anything contained in these Rules, if the Government takes any policy decision pertaining to admission, then the same shall be brought in to effect from that point of time as per the directives from the Government from time to time.
- (v) Students while studying in any college, if found indulging in anti-national activities contrary to the provisions of Acts and Laws enforced by Government or in any activity contrary to rules of discipline, will be liable to be expelled from the college without any notice by the Principal of the college.

**Action against ragging:** Maharashtra Prohibition of Ragging Act 1999 and Prevention and Prohibition of Ragging (Appendix 12 published in AICTE Approval Process Handbook 2011-12) and their amendments which may be published from time to time. The Maharashtra Prohibition of Ragging Act 1999 is in effect from 15th May, 1999 has the following provisions for Action against Ragging.

- a) Ragging within or outside of any educational institution is prohibited,
- b) Whosoever directly or indirectly commits, participates in, abets, or propagates ragging within or outside any educational institution shall, on conviction, be punished with imprisonment for a term up to 2 years and / or penalty, which may extend to ten thousand rupees.
- c) Any student convicted of an offence of ragging shall be dismissed from the educational institution and such student shall not be admitted in any other educational institution for a period of five years from the date of order of such dismissal.
- d) Whenever any student or, as the case may be, the parent or guardian or a teacher of an educational institution complains, in writing, of ragging to the head of the educational institution, the head of the educational institution shall, without prejudice to the foregoing provisions, within seven days of the receipt of the complaint, enquire into the matter mentioned in the complaint and if, prima facie, it is found true, suspend the student who is accused of the offence, and shall, immediately forward the complaint to the police station having jurisdiction over the area in which the educational institution is located, for further action. Where, on enquiry by the head of the educational institution, it is found that prima facie there is no substance, in the complaint received; he / she shall intimate the fact, in writing, to the complainant. The decision of the head of the educational institution shall be final.
- e) If the Head of the educational institution fails or neglects to act in the manner specified in section “d” above when a complaint of ragging is made, such person shall be deemed to have abetted the offence

and shall, on conviction, be punished as provided for in section “b” above.

- f) Undertaking from the candidate shall be taken while admitting the candidate in the Institute.
- g) Any Acts or its amendments which may be published from time to time by AICTE, Government or Judgments by Hon. Supreme Court of India, Hon. High Court of Bombay etc will be applicable to Candidates and Institutions covered under these rules of admission.

**If any of the statement made in application form or any information supplied or any certificate(s) submitted by the candidate in connection with his or her admission is later on at any time, found to be false or incorrect, his or her admission will be cancelled, fees forfeited and he or she may be expelled from the college by the Principal. Such candidates are also liable for penal action as per the provisions in the law.**

**Others:**

- (i) The medium of instruction for degree courses is English.
- (ii) The candidates are advised to ensure before applying that he/she is eligible for admission to the program as per the prevailing eligibility norms of the University. Admission of candidate will be treated as finally confirmed only on production of the Eligibility Certificate from the University to which the college is affiliated.
- (iii) Physical fitness: Head of the institution at his or her discretion may refer any candidate to the appropriate medical authority for ascertaining the physical fitness of the candidate to undergo the requirements of the course.
- (iv) The Head of the institution shall have the right to satisfy himself about the conduct and character of a candidate by verifying the antecedents of a candidate through the appropriate police-authority, before admitting him / her to the institute.

**Discipline:**

- Students will abide by the general rules of discipline laid down by the college authorities from time to time. In all the matters, the Principal's decision shall be final and binding on all students.
- Students while studying in the institute, if found indulging in Anti National activities contrary to the provision of Acts and Laws enforced by Government/competent authority or in any activity contrary to rules of discipline, will be liable to be expelled from the college without any notice by the Principal of the institute.
- Failure of the candidate in making full and correct statements in the application form and or suppression of any information and or submission of false documents shall lead to disqualification of the candidate for admission or even at later date during the admission process. Such a candidate will be de-barred from the institution. Therefore, the candidate is required to make only such claims which could be substantiated by relevant original documents.
- Every student should note that mere payment of fees does not entitle him to the grant of terms. He/she must attend all tutorials, sessional exams, periodical tests, continuous assessment activity and his/her performance therein must be satisfactory. He/she must have cleared all College dues before his examination form is forwarded to the examining authority.
- **The student are liable to be detained & will not be allowed to appear for the University examination if he/she does not attend minimum 80 per cent classes of theory & practical classes.**



- **In case, a student is not awarded scholarship/freeship, he/she has to pay the entire College fees.**
- All the students should park their vehicles at the assigned official parking space only.
- While being in the College campus, students must always display/wear Identity Card.
- Students must conduct himself/ herself properly, maintain proper behavior, observe strict discipline both on the campus of the College and also outside.
- Student is required to undergo a compulsory medical examination at his/her own expenses to ensure that he/she is medically fit & not suffering from any communicable diseases.
- Physical fitness: Head of the institution at his discretion may refer any candidate to the appropriate medical authority for ascertaining the physical fitness of the candidate to undergo the requirements of the course.
- Students must not lodge any complaint or make any representation regarding any matter connected with College to the press or other outside institution/agency etc. without forwarding the same through the Principal/management of the College.

**Prohibited:**

- Consumption of tobacco, alcohol or any other intoxicants within the college premises is strictly prohibited.
- Any act of indiscipline and misbehavior within the college premises is a punishable act.
- If any incident of **ragging** comes to the notice of college authority, the accused student would be expelled from the college. The College has constituted vigilance committee / anti-ragging committee -squad headed by the Principal.
- Candidate having any ragging record seeking admission to this college will not be admitted.
- A cell against Ragging, Harassment against women is functioning in the college in keeping with the Supreme Court guidelines & University guidelines.
- All offences of malpractices during examinations are dealt with by a special committee appointed by the College for the purpose. The decisions of the committee and the College management will be final and binding upon all the concerned students and parents.
- Possessing or using fire arms, lethal weapons, explosives, or dangerous or corrosive substances on the premises of the College is not permitted.
- Possessing or consuming any poisonous or stupefying drug or intoxicant in any form (such as Tobacco, Drugs, Narcotics, Pan masala, Gutakha and other similar things) in the College is strictly prohibited
- Smoking is strictly prohibited in the campus.
- Destroying or attempting to destroy or tamper with any official record or document of the College, Stealing or damaging of any property belonging to the College, staff member of the College or any other student, instigating violence or participating in any violent demonstrations or violent agitation or violent strike in the College is strictly prohibited.
- Violation of any of the rules and regulations of the College or orders of the Authority is strictly prohibited.
- Use of Mobile phones in the premises is strictly prohibited. Students will be responsible for any loss or damage of their mobile and other valuables in the college campus.
